



Draft Port Melbourne Waterfront Urban Design Framework 2013 Submission form

The City of Port Phillip has prepared the draft Port Melbourne Waterfront UDF 2013, which will enhance liveability, improve public spaces and secure a sustainable future for the Port Melbourne waterfront. It addresses the pressures on the waterfront area whilst recognising the rich maritime history and its unique character. The UDF has been revised following feedback from the community and key stakeholders and incorporates recommendations from independent technical studies on transport and access, views and vistas and design and development.

As part of revisiting the draft UDF 2011, the privately owned site at 1-7 Waterfront Place has been removed from the draft Port Melbourne Waterfront UDF 2013. Separate draft Design Guidelines for the site at 1-7 Waterfront Place have been prepared to guide any possible future development on the site.
