## Won't deliver:

- Funded Sustainable Business Network events, activities or one-on-one support (however existing businesses would be connected to Council's broader business support activities and climate change and sustainability matters would be included as part of this broader program where applicable)
- Proactive support to community greening (this could be considered further once Public Space Strategy is finalised)
- Proactive support to community mobilisation / education e.g. Enviro Leaders program (note funding is provided to the EcoCentre to support community education and engagement)
- PPA in collaboration with other inner city councils
- Any in-person events for businesses or community.

## Reduced capacity to:

- be present in the community e.g. participate in events, deliver workshops, provide speakers for events
- provide ad-hoc and responsive advice and support to the community.
