#### 1. Introduction

#### 1.1 Purpose

This report has been prepared for the City of Port Phillip (CoPP) and provides the methodology for, and recommendations arising from the review of individual heritage citations and three small precincts (HO315, HO316 and HO317) within the HO7 Elwood St Kilda Balaclava Ripponlea Precinct Review study area.

The need for this review was identified as part of the CoPP's on-going heritage program (see Background). As part of this program the CoPP is progressively updating heritage citations in the *Port Phillip Heritage Review* (PPHR) prepared prior to 2000 that no longer meet the standards set out in Planning Practice Note 1: *Applying the heritage overlay* (PPN1). This forms part of the ongoing review of heritage precincts across the municipality.

The purpose of the review is to ensure the updated citations meet the standards set out in PPNI and clearly describe what is significant about the heritage place or precinct, and how and why it is significant.

The key tasks included:

- Prepare new citations for places of local significance in accordance with PPNI including a history, description, and statement of significance, and identify any changes to heritage overlay (HO) controls, if required.
- Identify places that no longer satisfy the threshold of local significance and could instead become
  Contributory places within a heritage precinct, or be removed from the HO, as appropriate.
  The current citations for these places will not be updated.
- Review and update the citations for HO315, HO316 and HO317, as required, and update the gradings for properties in accordance with the new definitions (see Methodology).

This review has been prepared by CoPP heritage advisor, David Helms, and heritage consultant, Peter Barrett. The findings of the review have also been informed by the findings and recommendations of the Review of Heritage Precinct HO7 Elwood St Kilda Balaclava Ripponlea Precinct prepared by RBA Architects & Conservation Consultants.

Appendix I provides the full list of the heritage places assessed by this review.

#### 1.2 Background

The CoPP has taken a systematic approach to the review of heritage precincts in the municipality since the preparation of the Port Phillip Heritage Review (PPHR) in 2000. Since then, comprehensive reviews have been completed of HO3 (South Melbourne, Albert Park, Middle Park, St Kilda West) in 2008, HO1 (Port Melbourne) in 2011, HO4 (South Melbourne Industrial) in 2016, and HO6 (St Kilda East) in 2016-18. In addition, there have been 'gap' studies of St Kilda East, Elwood, and Fishermans Bend. Consequent changes to the HO controls arising from these reviews and gap studies have been implemented via a series of planning scheme amendments.

In 2019 RBA Architects & Conservation Consultants (RBA) were appointed to undertake the review of the HO7 Elwood St Kilda Balaclava Ripponlea precinct and environs, which includes.

- The division of the HO7 precinct into smaller sub-precincts and the creation of new citations.
- The assessment of two new heritage precincts.
- The assessment of new individual heritage places outside of the HO7 precinct.
- The review of a select number of places with current PPHR citations that are within the revised or new heritage precincts or associated with the new individual heritage places being assessed.

As an associated task, the CoPP identified 121 individual heritage citations and three small precincts within the HO7 study area that require updating. Most are within the current HO7 precinct, while a smaller number are within individual HOs. The precincts and places, which are listed in the tables in Appendix A include:

- HO315 Inkerman Street (East), HO316 Carlisle Street (East) and HO317 (Hotham Street) (Table A.1)
- 59 houses (Table A.2).
- 38 flats (Table A.3)
- 17 commercial or mixed-use buildings (Table A.4).
- 7 churches, government (police station, former post office) or community buildings (Table A.5).

The PPHR citations selected for review have been identified by Council's heritage advisor. They were prepared prior to 2000 and often have inadequate historic and descriptive information and statements of significance that do not meet standards set out in PPN1.

### Methodology

This review has been prepared in accordance with the Australia ICOMOS Charter for Places of Cultural Significance, 2013 (the Burra Charter) and its guidelines, and in accordance with relevant guidelines including PPN1. All terminology is consistent with the Burra Charter.

#### The tasks included:

- Historical research using selected primary (Council building plans and records, land title
  information, property sewerage plans, newspaper, and journal articles) and secondary (heritage
  studies) sources.
- Consideration of the association of the place or precinct with themes identified in new draft *Port Phillip Thematic Environmental History* (2021).
- Site inspection. A key task was to note any changes since the original assessment and whether this has affected the integrity or intactness of the place.
- Comparative analysis. As the purpose is to review and confirm rather than establish significance, detailed comparative analysis has not been carried out for all places. Detailed comparative analyses have been prepared where the original documentation was lacking, or the historic research and physical analysis has revealed new information about the place that reveal new aspects of significance not identified before.
- Assessment against the Hercon criteria and preparation of a statement of significance in accordance with PPNI.

The review was prepared in two stages:

#### Stage I

The citations included in Stage I were prepared as part of the heritage studies carried out by the former City of St Kilda in 1982, 1985 and 1992 and were not reviewed or updated when the PPHR was prepared in 1998. Many of these have only brief or cursory descriptions and histories (some have none) and very brief statements of significance. None have a comparative analysis.

These citations required the preparation of a new history, description, and statement of significance, as well as some comparative analysis to confirm and/or establish the significance of the place.

For Stage I the descriptions and statements of significance were prepared by Peter Barrett based upon his own site inspection, and the history and comparative analysis prepared by David Helms. Both the descriptions and statements of significance were prepared in batches of approximately 8-10 sites, which were reviewed by the CoPP. Mr Barrett undertook one final review of each citation based on feedback by the CoPP.

#### Stage 2

The citations included in Stage 2 were prepared as part of the 1998 PPHR or are earlier citations that are more comprehensive. They have a history and description, and a more fulsome statement of significance, which in the case of the 1998 citations includes reference to the Hercon criteria.

These citations required a review and update of the descriptions and histories, additional comparative analysis where necessary, and the preparation of updated statements of significance.

Also forming part of Stage 2 was the review of the citations for the HO315 Inkerman Street (East) precinct, HO316 Carlisle Street (East) precinct and HO317 Hotham Street precinct, which were

prepared as part of the 1998 PPHR. These citations required a review and update of the descriptions and histories, additional comparative analysis where necessary, and the preparation of updated statements of significance. In addition, the HO316 precinct required an assessment of potential extensions in Carlisle Street and Hawsleigh Avenue.

The gradings of each property also required updating in accordance with the new grading definitions, which have been prepared to ensure the gradings are consistent with PPNI and reflect the correct level of significance for the place (See Table I, below). A key issue with the current gradings is a Significant place includes a place of local or State significance, as well as places that are not of individual significance, but are contributory to a precinct only.

For Stage 2, the places and three precincts were reviewed by David Helms, who prepared the description, history, comparative analysis (as required) and updated statements of significance.

#### Findings and recommendations

The tables in Appendix I provide the recommendations for each precinct and place. In summary:

- New statements of significance have been prepared for HO315, HO316 and HO317, and the gradings of properties have been updated in accordance with the new definitions (see Table A.I).
- The boundaries of HO317 precinct do not change, and only one change is recommended for the HO315, which is to remove one place (247-249 Inkerman Street), which will form part of a new group listing of flats designed by Michael R.E. Feldhagen.
- The following extensions to HO316 are recommended:
  - 332-336 Carlisle Street and 2-24 Hawsleigh Avenue. These are associated with the rapid development that occurred in the early twentieth century following the opening of the electric tramway, which encouraged higher density development including the building of flats.
  - 311, 313, 364, 364A Carlisle Street. These comprise one house and five post-war flats that demonstrate how post-World War Two migration resulted in a growing Jewish community, which included many individuals who, interested in recreating familiar lifestyles or with an eye to property development, regularly engaged a select group of Jewish émigré architects to design houses, flats and apartment blocks, which introduced concepts of European-influenced modernism.
  - 342, 378 Carlisle Street. These demonstrate the importance of St Kilda and Balaclava as an epicentre of flat building in Melbourne. Bellevue Lodge (342) is also of individual significance.
  - 356 Carlisle Street. This is Non-contributory property but is within the extended precinct boundary.
- 87 individual places are of local significance and a new updated citation has been prepared, or they have been specifically identified in the new or updated precinct citation. In three cases, combined citations have been created for places that have a shared history and significance:
  - La Tourelle, 47A Brighton Road and La Rochelle, IA Dickens Street, both in Elwood.
     Both designed by W.H. Merritt for the same client on adjoining properties
  - Santa Fe and Las Palmas, 43 and 45 Mitford Street, Elwood. Both designed by J.H.
     Soderburg in similar Spanish Mission or Mediterranean influenced styles.
  - Houses, 29-31 & 33 William Street. Victorian bi-chromatic brick houses built for the Smith family and likely designed by Alfred Smith.
- Four places now form part of group listings, which have a single citation:
  - The flats at 169 Hotham Street, Balaclava, and 247-249 Inkerman Street form part of the Feldhagen Flats Group Listing I (prepared by RBA).
  - Barkly Lodge, 289 Barkly Street, Elwood and Burnett Lodge, 9-11 Burnett Street, St Kilda form part of the Benshemesh Flats Group Listing I (1948-1954) (prepared by RBA).
- One new citation has been prepared for the former Cable Tram Depot building that forms part of the Grosvenor Hotel complex but has a separate development history.
- 34 places become Contributory to the precincts of which they form a part. The citations for these places have not been updated.

#### **HO** control changes

Generally, the places reviewed will either retain the current individual HO or become part of the new HO applying to the precinct of which it forms a part.

Specific changes in accordance with PPN1 include:

- Transfer of places from a current individual HO to a new precinct HO:
  - St Colman's Church Complex, 291 Carlisle Street, Balaclava (currently, HO75) to the updated HO316 precinct, retaining interior controls for the church and school/hall, consistent with the current HO schedule.
  - Hawsleigh Court, 2B Hawsleigh Avenue, Balaclava (currently HO375) to the updated HO316 precinct, retaining tree controls, consistent with the current HO schedule.
- The inclusion of 311, 313, 332, 334, 336, 342, 360, 364, 364A & 378 Carlisle Street and 2-24 Hawsleigh Avenue, Balaclava within HO317. 342 Carlisle Street is one of the places of individual significance assessed by RBA.

In addition, the Review of Heritage Precinct HO7 Elwood St Kilda Balaclava Ripponlea Precinct prepared by RBA Architects & Conservation Consultants recommends the following changes:

- Transfer of places from a current individual or precinct HO to a new individual or group listing HO:
  - Grosvenor Hotel, 10 Brighton Road, Balaclava (currently, HO7 precinct) to new individual HO.
  - Former Cable Tram Office, 16 Brighton Road, Balaclava (currently, HO7 precinct) to new individual HO.
  - Yurnga, 36 Brighton Road, Balaclava (currently, HO7 precinct) to new individual HO.
  - Flats, 169 Hotham Street, Balaclava (currently, HO315 precinct) and 247-249 Inkerman
     Street (currently, HO7 precinct) to the Feldhagen Flats Group Listing I HO.
  - Barkly Lodge, 289 Barkly Street, Elwood (currently, individual HO35) and Burnett Lodge, 9-11 Burnett Street, St Kilda (currently, HO5 precinct) to the Benshemesh Flats Group Listing I (1948-1954).
- Transfer of the following places from a current individual HO to a new precinct HO:
  - St Kilda Police Station, 92 Chapel Street (HO290) becomes part of the new Carlisle Street Commercial & Public precinct (recommendation by RBA).
  - Shops and residences, 268-276 Inkerman Street, St Kilda East (HO162) becomes part of the new Inkerman Street Commercial precinct (recommendation by RBA).
